**Yard Debris-** One of the services that is paid for by our HOA dues is the maintenance of the common areas such as the entrances and areas surrounding the retention ponds. Our contractor has reported that yard debris (limbs, grass clippings, etc) has been discarded in those areas and is causing difficulty in maintenance. If they have to take time to remove yard debris, they will charge us for that service. If you have yard debris, you must take it to the landfill for disposal. If you discard it on community property, it will impact all homeowners.

**Architectural Review-** Please remember that any alterations to the exterior appearance of your home must follow HOA guidelines. This means that before making a change you must submit a proposal to the Architectural Review Committee through Ryan Hymes. This includes changes such as a new color for your front door, removing or changing the banisters on your front porch, installing a new fence or replacing your existing fence with a new style. If you have any questions about a change you are considering, contact Ryan Hymes and he will have the answer or get it for you as soon as possible.
